

Membership Terms and Conditions



1. Membership Term

- a. All Gold Creek Country Club (GCCC) memberships have a minimum contract duration of twelve months from the commencing date of this agreement. By completing and signing this application form, you are entering into a contract for at least this minimum period.
- b. Following the minimum contract duration, GCCC will automatically renew your membership, unless GCCC terminates the partnership on reasonable grounds or has been notified by the member in writing to conclude the membership prior to the minimum contract duration.
- c. Memberships cannot be put on hold apart from extenuating circumstances which will be reviewed on a case-by-case basis. This includes serious medical conditions where a doctor's certificate will be required.

2. Membership Conditions

- d. By becoming a member, you acknowledge that you understand the services and facilities available at GCCC and have familiarized yourself with all terms and conditions
- e. By becoming a member, you acknowledge the different membership categories offered and the different levels of access to GCCC facilities and services.

3. Financial Terms

- a. Members have options for upfront or direct debit payments.
- b. You acknowledge and agree to pay the designated joining fee upon joining GCCC:
 - i. For 5-Day and 7-Day memberships: \$800
 - ii. For Younger Member memberships (26 to 35 years old): \$400
 - iii. For Intermediate memberships (18 to 25 years old): \$200
 - iv. For Junior memberships (under 18): \$200
- c. You acknowledge that the designated membership fee is payable either in full immediately or by instalments:
 - i. For 7-Day memberships: \$2,550
 - ii. For 5-Day memberships: \$2,300
 - iii. For Younger Member memberships (26 to 35 years old): \$1,950
 - iv. For Intermediate memberships (18 to 25 years old): \$1,150
 - v. For Junior memberships (under 18): \$285
- d. Upon commencement of membership, the membership invoice will be emailed to the member's designated contact. The invoice will provide the option to pay the membership fee in full or select a payment plan. All direct debit payments are processed through the EzyPay platform:
 - i. It is your responsibility to have the allocated funds in your account. GCCC or Ezy-Pay cannot be held responsible for insufficient funds in your nominated account.
 - ii. Failure to pay as per the agreement will result in the immediate suspension of our partnership until payment is made.

- iii. If your membership lapses for more than 60 days, the joining fee will be reapplied upon rejoining.
- iv. Please be advised we have a no-refund policy in place.

4. Benefits and Deliverables

- f. Membership benefits vary depending on the category selected by each member.
- g. Family Membership includes two adults and two children up to 21 years of age.

5. Use of Facility

- a. To play the course, your membership must be active, and you must not have any outstanding fees.
- b. You must adhere to GCCC's dress regulations which include but are not limited to footwear, shorts or trousers, and collared shirts.
- c. The facility may at times be closed due to public holidays, general maintenance programs, or other unforeseen circumstances. Where possible, these dates and times will be communicated in advance. Course availability and services may vary or change due to seasonal or other conditions. There are no refunds or credits issued for such days.
- d. A member must be 18 years of age or older to hire and operate a golf cart. Members under the age of 18 may require a parent or guardian to sign their agreement.

6. Insurance and Liability

- a. GCCC reserves the right to suspend or cancel a membership for inappropriate behaviour or breach of GCCC's terms and conditions. Inappropriate behaviours include but are not limited to: misconduct under the influence of drugs or alcohol, being abusive to staff or other members/visitors, breach of membership contract, or being deemed unfit to use any part of the facilities.
- b. At all times prior to using the facility, you acknowledge that you are of sound fitness and not at the facility against your doctor's orders.
- c. Should you injure yourself or get hurt while using GCCC's facilities or services, you are fully responsible for your injuries.
- d. Members are responsible for any claims, damages, or losses arising from their activities (including associates) at GCCC.
- e. Members agree to indemnify and hold GCCC harmless from any claims, damages, liabilities, losses, or expenses from their activities.
